#### **SESSION** Advancing Patient Advocacy and Community Engagement

**Dr. Adotama** is a board-certified dermatologist. He is an Assistant Professor at the Ronald O. Perelman Department of Dermatology at New York University Grossman School of Medicine. His clinical interests include skin disorders that disproportionately impact patients of color, particularly scarring alopecia, and autoimmune blistering disorders. He is a co-founder of the Skin of Color Section at NYU, which offers personalized, evidence-based treatment for conditions affecting people with black and brown skin. Dr. Adotama has written multiple peer-reviewed medical publications, engaged in clinical trials, contributed to dermatologic textbooks, and has given presentations around the world. He sits on various advisory boards and actively participates in service committees. Dr. Adotama always aims to deliver high quality, patient-centered, culturally competent care to all of his patients.

#### Crystal Aguh, MD, FAAD

Associate Professor; Director, Ethnic Skin Program; Director, Ethnic Skin Fellowship, Department of Dermatology, Johns Hopkins School of Medicine

#### **SESSION A Closer Look at Underrepresented Dermatologic Diseases**

**Dr. Aguh** is an Associate Professor of Dermatology and Director of the Ethnic Skin Program at the Johns Hopkins School of Medicine. Dr Aguh's area of research focuses primarily on skin conditions that disproportionately impact minority populations, with particular emphasis on cicatricial alopecia. She has published four books and numerous peer-reviewed journal articles on hair loss and given multiple national and international talks on these topics. As a result of her work, Dr. Aguh is the recipient of several prestigious research awards & grants from the National Institutes of Health (NIH), Skin of Color Society, Johns Hopkins Medical Institutions and the Dermatology Foundation. In April 2019, Dr. Aguh, along with other prominent awardees including then-former Vice President Joe Biden, was honored by the National Minority Quality Forum with the 40 under 40 Leaders in Minority Health award for her academic work. Dr. Aguh completed her residency at Johns Hopkins School of Medicine, serving as the chief resident in her final year training. She received her undergraduate degree from Duke University and earned her medical degree from the University of Pennsylvania School of Medicine, with honors, earning induction into Alpha Omega Alpha Honor Society.

#### Andrew F. Alexis, MD, MPH, FAAD

Vice-Chair for Diversity and Inclusion Department of Dermatology & Professor of Clinical Dermatology, Weill Cornell Medical Center

#### **SESSION Delving Deeper into Outcome Measures**

**Dr. Alexis** is the Vice-Chair for Diversity and Inclusion for the Department of Dermatology and Professor of Clinical Dermatology at Weill Cornell Medical College in New York City. He is the former Chair of the Department of Dermatology at Mount Sinai Morningside and Mount Sinai West. Having served as Director of the first-of-its-kind Skin of Color Center for over 15 years, his work has helped to advance patient care, research, and education pertaining to dermatologic disorders that are prevalent in populations with skin of color.

Dr. Alexis has published more than 100 articles in peer-reviewed journals including the British Journal of Dermatology, Journal of the American Academy of Dermatology, and JAMA Dermatology among others. He has co-edited two textbooks and authored over 10 book chapters. Dr. Alexis is a frequent lecturer at national and international conferences and has been invited as a Visiting Professor or Grand Rounds speaker at many prestigious academic institutions. He is Past President of the Skin of Color Society and is a member of the Board of Directors of the Scarring Alopecia Foundation.



#### Donna Atherton, EdD, CLC, MSW, DUSP Fellow

Founder, Chief Mission Officer, International Association of Hidradenitis Suppurativa Network, Inc.

#### **SESSION** Advancing Patient Advocacy and Community Engagement

**Dr. Atherton** is a retired psychotherapist, entrepreneur, and nationally recognized patient advocate dedicated to transforming the lives of individuals living with chronic conditions. She is the Founder and CEO of Bath Blocc, a wellness brand offering handmade, honey-infused bath and body products for sensitive skin, and the Founder of the International Association of Hidradenitis Suppurativa Network (IAHSN), a nonprofit organization focused on advocacy, education, and mental health support for people living with Hidradenitis Suppurativa (HS).

Drawing from her personal journey with HS, Dr. Atherton integrates holistic wellness, resilience coaching, and mental health strategies to help individuals take control of their well-being. With a warm and empowering presence, she provides coaching, creates self-care tools, and leads initiatives that amplify patient voices and promote healing from the inside out.

Dr. Atherton's work bridges science, compassion, and community. She continues to write, speak, and lead with the belief that everyone deserves dignity, effective care, and the power to live well—no matter their diagnosis.

#### Jarrett Brown

**Jarrett Brown** is a vitiligo advocate, public speaker, and advisory board member for the Beautifully Unblemished Vitiligo Support Group. He serves on the Advocacy Committee of the Global Vitiligo Foundation and has hosted public forums focused on the intersection of skin health and mental health. Jarrett also participates in multiple research initiatives aimed at improving representation and outcomes in dermatology. Through his platform Jarrett Speaks, he shares stories that promote awareness, inclusion, and empowerment.



#### Angel S. Byrd, MD, PhD

Associate Professor, Department of Dermatology, Howard University College of Medicine

#### SESSIONS Beyond Race and Ethnicity | Advancing Patient Advocacy and Community Engagement

**Dr. Byrd** was born and raised in Edwards and Jackson, Mississippi. She obtained her BS ('04) from Tougaloo College in Tougaloo, Mississippi and MD,PhD ('16) from Warren Alpert Medical School of Brown University in Providence, Rhode Island. She completed an Ethnic Skin Postdoctoral Fellowship at Johns Hopkins University School of Medicine (JHUSOM) under the direction of Dr. Ginette Okoye. Currently, she is an Associate Professor at Howard University College of Medicine and Adjunct Assistant Professor at JHUSOM (Departments of Dermatology) where her work centers on the establishment of tissue biobanks to understand the immunopathological mechanisms contributing to skin of color diseases, particularly among African-American patients with Hidradenitis suppurativa. Her main research focus is elucidating the unreported roles of neutrophils and the innate immunity in the induction of local and systemic immune dysregulation. Dr. Byrd leads multidisciplinary collaborative projects with the overarching goal of establishing a scientifically-driven approach to treatment options for patients suffering from these debilitating diseases. Of much importance, she continues to pay-it-forward along her journey devoting time to training and investing in the next generations of scientists and physician scientists as well as engaging in community outreach. She has contributed to the scientific literature, given numerous lectures, national/international talks, and has been featured on the BET 33rd Annual UNCF An Evening of Stars® international program, recognizing her as one who is "changing the face of science, one mind at a time."

#### SESSION co-chair | Meeting the Challenge: Celebrating Milestones, Achievements & Mentorship

**Dr. Callender** is an internationally recognized Board-Certified Dermatologist who is known for her sensitive, caring, and cutting-edge approach to the management of hair loss in women and the treatment of pigmentation disorders across all skin types. Dr. Callender has held leadership positions across a wide spectrum of dermatological organizations, including serving as President of American Dermatological Association, the Women's Dermatologic Society (WDS), the Skin of Color Society and the National Medical Association's Dermatology Section. She has also served on the Board

of Directors of the American Academy of Dermatology (AAD), where she was a member of the Executive Committee and is the current President of the American Acne & Rosacea Society. Dr. Callender has a deep and enduring commitment to Dermatology and has made significant contributions to the science of Dermatology, where she has published over 100 peer-reviewed articles, 28 textbook chapters, edited 2 textbooks and participated in over 60 clinical trials. Dr. Callender is frequently invited by her colleagues, both nationally and internationally to share her expertise, and has made 354 presentations in the United States and around the world. She is the Founder and Medical Director of the Callender Dermatology & Cosmetic Center and Callender Center for Clinical Research, which are both located in the Washington, DC metropolitan region. ## SESSIONS Delving Deeper into Outcome Measures | A Closer Look at Underrepresented Dermatologic Diseases

**Dr. Werth** is a Professor of Dermatology and Medicine at the Perelman School of Medicine at the University of Pennsylvania and Chief of the Division of Dermatology at the Philadelphia Veterans Administration Hospital. Dr. Werth earned her medical degree from Johns Hopkins University School of Medicine in Baltimore, Maryland. She completed a residency in internal medicine at Northwestern Memorial Hospital in Chicago, Illinois, and dermatology residency and immunodermatology fellowship at New York University School of Medicine in New York, funded by the NIH and Dermatology Foundation. She joined the faculty at Penn in 1989 and has developed an internationally recognized program in autoimmune skin diseases.

She is a co-founder of the Rheumatologic Dermatology Society and previous president of the group. She is co-founder of the Medical Dermatology Society, and a recipient of their lifetime achievement award. She initiated the combined internal medicine/ dermatology residency program in the U.S., which has successfully trained prominent leaders in complex medical dermatology. She has a longstanding interest in clinical and translational research pertaining to autoimmune skin diseases, including cutaneous lupus erythematosus, dermatomyositis, and autoimmune blistering diseases, with a focus on improving the outcomes of autoimmune dermatologic diseases. She has developed and validated disease severity tools now used in many international trials for these diseases, with a goal to advancing evidence for current and new therapeutics. Her laboratory studies include studies in cutaneous lupus and dermatomyositis that relate to pathogenesis and heterogeneity of response to treatment, and ultraviolet light effects on skin. Recent clinical studies have examined mechanistic effects of therapeutics in CLE, as well as subset-specific expression of cytokine signatures. She has received numerous honors for her work, including the lifetime achievement award from the Medical Dermatology Society, the Rose Hirschler Award from the Women's Dermatologic Society, and the American Skin Association's Research Achievement Award in Autoimmune & Inflammatory Skin Disorders, and the Lifetime Career Educator Award, Dermatology Foundation. Her work has been funded by the Dermatology Foundation, NIH, DOD, the Veterans Administration, the Lupus Research Alliance, the Lupus Foundation of America, the Myositis Association, the International Pemphigoid Foundation, CARRA, and industry.

As director of Virginia Commonwealth University Massey Comprehensive Cancer Center, Robert A. Winn, M.D., leads the nation in optimizing cancer health care outcomes for all and spearheading interdisciplinary approaches to cancer disparities research. Just the fourth director of Massey since its 1975 National Cancer Institute designation, Winn oversees a center of nearly 150 scientists and clinical investigators.

Dr. Winn is nationally recognized for his community engagement efforts in promoting new approaches to building trust and increasing awareness for cancer research, screening, prevention, treatment, and survivorship, including the Robert A. Winn Excellence in Clinical Trials Award Program, a \$114 million training and education program in partnership with the Bristol Myers Squibb Foundation dedicated to increasing participation and representation in clinical trials, and the nationally heralded Facts & Faith Fridays conversation series.

In 2024, Winn served as the chair of the steering committee for the American Association for Cancer Research Cancer Disparities Progress Report, outlining the progress made against cancer in the U.S., and the large segments of the population which have not benefited from the scientific advances and who continue to shoulder a disproportionate cancer burden.

Winn holds a B.A. from the University of Notre Dame and an M.D. from the University of Michigan Medical School in Ann Arbor. He completed an internship and residency in internal medicine at Rush-Presbyterian-St. Luke's Medical Center in Chicago and a fellowship in pulmonary and critical care medicine at the University of Colorado Health Sciences Center in Denver.

**Dr. Yoo** is a Korean American, dual board-certified cosmetic dermatologist and Mohs surgeon and clinical assistant professor of Dermatology at the Icahn School of Medicine at Mount Sinai in NYC. She graduated with a BS in Biology from Massachusetts Institute of Technology and obtained a master's degree in public policy from Harvard University. After completing her dermatology residency at Albert Einstein College of Medicine, she pursued her Mohs Micrographic Surgery fellowship at Yale School of Medicine. She is the founder of the Clinical Research Center of New York and conducts clinical trials for numerous cosmetic, pharmaceutical, and energy-based device companies.



As a spokesperson for the Skin Cancer Foundation, she is involved in advocating for skin cancer prevention and lobbying Congress to bring improved sunscreen filters to the US. As a Skin of Color Society board member, she is passionate about increasing diversity in clinical trials. She is an avid marathon runner and is an Abbott World Marathon Majors Six Star Finisher.
